

# **EQUIPMENT RENTAL AGREEMENT NO-TILL DRILL**

I, the undersigned Lessee, hereby agree to rent and lease from the Emmet Conservation District (Lessor), and Lessor agrees to, and now does rent a No-Till Drill (hereinafter called equipment), subject to the terms and conditions listed below. This agreement between the Emmet Conservation District and the undersigned Lessee is in effect upon the signing and dating of this agreement.

1. The fee schedule is as follows; \$10 flat rental fee + \$7 per acre planted.
2. A deposit of 25% is required at the time the contract is signed. Balance is due no later than 30 days from the date of invoice, which will be sent immediately following use of the equipment.
3. Rental is scheduled in increments of four (4) day consecutive periods. A \$50.00 per day fee will be assessed for any time that exceeds four (4) days, unless previously arranged with the administrator.
4. The Lessee hereby represents that he does have in force a valid liability insurance policy and agrees to hold the Emmet Conservation District, officers, employees and agents harmless as to any liability which may arise out of the landowner's transportation and/or use of the no-till drill.
5. After using the no-till drill, Lessee must spray all parts of the drill off with a water hose to eliminate any soils remaining on the discs or any other parts of the drill. It is Lessee's responsibility to remove any unused seed from hopper and tubes. A cleaning fee of \$100 will be charged to the lessee if the drill is not clean when returned.
6. The Lessee will furnish all labor, power, lubrication and supplies necessary to operate and transport this equipment.
7. The Lessee shall be responsible for any damage to the equipment due to negligence while in the possession of the Lessee, except ordinary wear and tear as determined by the Lessor.
8. **Speed limit while transporting the drill is not to exceed 25 mph.**
9. The Lessee shall not allow fertilizer to be put through the no-till drill.
10. The Lessee is responsible for picking up and returning equipment to a predetermined central location, or as directed by Lessor.
11. Lessee grants to Lessor, or its agents permission, to enter the premises of the Lessee at any time to inspect the equipment and to secure the return of the equipment.
