EDUCATIONAL RAIN GARDEN PROJECT



(under construction August '08)

This past year the Emmet Conservation District partnered with MSU Extension Master Gardeners and Tip of the Mitt Watershed Council to install an educational rain garden in an existing stormwater basin located on county property at 3434 M-119. Funds for the project came from the Petoskey-Harbor Springs Area Community Foundation in the amount of a \$3000 grant, Petoskey Rotary Charities grant for \$1500, J.F. New grant for \$1000, and the

Petoskey Garden Club \$3000 toward the purchase of native plants. Other assistance came from Emmet County DPW in the form of donated compost and mulch and All Season's Maintenance, Inc. helped out by providing equipment and labor for part of the work. The rain garden was planted with the help of volunteers on September 20th. Further native plants will be added in the spring of 2009.

The goal of the rain garden project is to reduce and manage stormwater pollution, show the effectiveness of rain gardens in reducing stormwater runoff, educate the public about the benefits of using native plants and increase residents' understanding of their connection to stormwater pollution with innovative education.

DISTRICT WEBSITE

The Emmet Conservation District has had a website for about 1½ years. We are continuing to add new items of interest to the website. The quickest way to get information about the spring and fall tree sales is to check our website. When the new catalog is prepared it is posted on the website first before anywhere else. We add new forestry articles from Bill Cook as they become available on a regular basis. Links to other websites that we think might be of interest to you will be added in the very near future. NO TILL DRILL RENTAL



195 acres were planted this year with our No Till Drill. This was over a 300% increase in the number of acres planted last year. There are many benefits to planting with the no till drill. Some of those are as follows; decrease soil erosion, reduce soil compaction, use less fuel and labor than conventional planting, and soil retains moisture longer.

The no till drill is available for rent at a reasonable fee. The drill is a Tye Pasture Pleaser (End Wheel). It is equipped with an

internally fluted, adjustable seeder that accurately meters out small grains such as wheat, rye, barley, oats, rice, and soybeans. Please call the office for rates and to schedule when you would like to use the no till drill.

GROUNDWATER STEWARDARDSHIP PROGRAM

This program provides one-on-one technical assistance to area agricultural producers by conducting:

- Farm-A-Syst which identifies potential risks posed by farmstead operations. Fact sheets provide educational information and list reference people to contact if questions arise. The work sheets use a simple question and answer format to evaluate farmstead practices that may pose a risk to groundwater. A Farm-A-Syst is voluntary and confidential. All materials stay with the farmer. It is available free of charge.
- Crop-A-Syst which will assist the farmer to develop and implement a management plan that prevents contamination of groundwater and surface water resources and maintains economic crop production. The plan will be in conformance with applicable Michigan-Right-To-Farm guidelines and in compliance with applicable state and federal environmental regulations. The farmer then can apply for the Michigan Agricultural Environmental Assurance Program (MAEAP) verification.
- Orchard-A-Syst
- Greenhouse-A-Syst
- The program sponsors the Emergency Tube Program that helps first response vehicles to determine possible contamination factors in case of a farm emergency.

Cost share money is available for these items:

- Abandoned well closures
- Temporary Pesticide Storage
- Manure Test / Analysis
- Intensive Rotational Grazing
- Emergency Spill Kits
- Anti-Backflow Devices
